DISH Network One-Rate Service Agreement

This is an agreement ("Agreement") between you and DISH Network for the provision of satellite-delivered programming services.

In consideration of receiving a reduced rate on a satellite TV system, you agree to subscribe to one of the eligible DISH Network One-Rate packages set forth above for a minimum period of 12 consecutive months. In the event that your DISH Network Commercial One-Rate package is disconnected or downgraded from the required minimum before the expiration of 12 consecutive months, you agree to pay DISH Network a cancellation fee equal to the amount of your rebate within ten (10) days of the downgrade or disconnection of service.

This is a limited time offer for new DISH Network commercial customers who purchase, install and activate a Model 3720, 4000, 4720 or 5000 satellite TV system. Completed and signed DISH Network Commercial One-Rate Service Agreement and \$199 Rebate Form, and appropriate Viewing Agreement must be submitted to DISH Network by your retailer on or before October 15, 1999 to receive your rebate. DISH Network is not responsible for retailers who fail to return the DISH Network Commercial One-Rate Service Agreement and \$199 Rebate Form within the required time period. Rebate is only available to commercial customers, and only one rebate is available per commercial establishment. Rebate may not be combined with any other offer. DISH Network shall determine eligibility in its sole and absolute discretion. All prices, packages and programming subject to change without notice.
